You'll learn how Noah might have cared for all the animals and how the Ark would be big enough to fit them all on board. See everything from how he might have built the ship, the story of the Ark, and what life may have been like for Noah and his family. The day is yours to explore the park, enjoy lunch and spend time taking it all in. After a full day at the park, head back to your hotel to enjoy an evening of rest and relaxation. Tomorrow we move onto the Creation Museum! B)

Day 4 - The Creation Museum and Farewell Dinner

The 75,000 square foot museum cost \$27 million to build in 2007! Reflecting young Earth Creationist beliefs, this museum depicts humans and dinosaurs coexisting. This state of the art museum allows you to venture through biblical history, stunning exhibits, botanical gardens, planetarium, zoo, and so much more! At the heart of the Creation Museum is a chronological retelling of Biblical history in seven parts called the Seven C's. Guests step back in time, beginning with The Creation, and fast-forward to Christ's return. Later in the afternoon, head towards Indianapolis where you will enjoy a spectacular farewell dinner with the group before returning to your hotel. (B, D)

Today we journey home. The spectacular journey through biblical times will have moved you and inspired you. The drive home won't disappoint as there is still fun to be had! Your guide will entertain you with games and movies to help pass the time as we make the journey home to Kansas City and Nebraska! (B)
